









> Evidence of Citizenship Required in Philippines

Warrant officers, Chief Petty Officers, Petty Officers and other enlisted men and their families are advised that the Secretary of State has instructed the Navy Department that any of the above persons proceeding to the Philippine Islands on assignments, and members of their family, must carry with them documentary evidence such as birth or baptismal certificate in order that they may be able to establish their American citizenship if called upon to do so.

The Chief of the Bureau of Navigation has issued instructions that he considers it desirable that all Naval personnel comply with the request of the State Department and be prepared with the following documentary evidence:

a. Native citizen.

A birth certificate, an affidavit of a blood relative, or an affidavit by two persons who have known the applicant for passport for twenty years, may be submitted.

A birth certificate which may be obtained from the Bureau of Vital Statistics in the city, town or county in which the applicant was born,

brief family history of the applicant for 20 years is required.

In the affidavits of non-relatives they should state the source which the knowledge was acquired to show that they have known the applicant for 20 years and that to their knowledge the applicant is a native born citizen of the United States.

A baptismal certificate if recorded within a few weeks after date of birth

will be accepted.

In the cases of native born wives of commissioned officers of the Navy who were married subsequent to September 22, 1922, they are required to furnish evidence of their citizenship by a birth certificate, a baptismal certificate, or an affidavit of a blood relative or an affidavit by two persons who have known the applicant for passport for 20 years.

b. Persons claiming citizenship through naturalization of self or parent.

(1) A person naturalized in his own right must transmit with his application his certificate of naturalization.

(2) The child of a naturalized citizen claiming citizenship through the naturalization of the parent must state in the application the exact date of immigration to the United States and submit the parent's certificate of naturalization.

(3) A child born abroad after the naturalization of the parent must submit with his application evidence of the nature described in the preceding rule.

(4) If the applicant comes within the provisions of rules (1), (2), or (3), his old passport will be accepted in lieu of a certificate of naturalization, provided the application upon which a previous passport was issued is found to contain sufficient information as to the naturalization of the applicant from the parent.

c. Persons claiming American citizenship through birth abroad of an American father:

Persons who come within this category should submit documentary evidence of the nature above outlined to establish the American citizenship of his or her father.

d. If, in a particular case, an individual may not be able to determine from the foregoing the evidence which would establish satisfactorily his or her American citizenship for passport purposes, a request for further information may be addressed to the Passport Division, Department of State, Washington, D. C.


"Plain Cook" Arouses Polish Army
